

## TERMS AND CONDITIONS Pluxee x UNO Digital Bank Promo Mechanics

- 5. The customer will need to register a valid and updated mobile number and email address with UNO Digital Bank's sales agent in the participating merchant branch.
- 6. The customer must apply for any of the loanable amount below to receive his FREE gift of Pluxee Gift code.

- 7. Loan term shall vary from six (6) to eighteen (18) months. A loan term of twenty-four (24) months shall only be made available for items with a purchase price of more than ONE HUNDRED THOUSAND PESOS (Php 100,000.00).
- 8. Customer must provide a 20% down payment upfront to the merchant in any mode of payment accepted by the merchants.
- 9. The customer must be granted of the credit limit and approved of the loan before receiving the FREE Pluxee Gift code.
- 10. Customer will receive the FREE Pluxee Gift code via the email address he submitted within 48 hours upon approval of loan.



- 11. Customer must download the UNO Mobile App from the Apple App Store or the Google Play Store, and register with a valid ID to create an #UNOready Savings Account
- 12. Customer must pay their monthly installments through their #UNOready Savings Account via automatic debit arrangement.
- 13. Customer must have sufficient balance in their #UNOready Savings Account to pay off their monthly installment
- 14. The promo and its corresponding offer in the form of a Pluxee Gift code is not convertible to any other form of reward.
